Assessment methods of student's initial preparation:

Oral interview

The admission test is compulsory for the enrollment in II Level degree course in European Heritage, Digital Media and the Information Society, and it consists of an individual interview aimed at assess the adequacy of the candidate's preparation.

During the interview, the possession of knowledge in disciplinary fields related to the course of study is verified.

The admission interviews have been scheduled for each academic year in three sessions and they take place in the months of September, December and April.

The Commission is appointed by the CdS Board (Degree Course Board) and it is composed by three full members and three deputy members. The evaluation is expressed in thirtieths (minimum score for admission to the course: 18/30). In case of failure, the candidate can apply for next test sessions.

Subjects covered by the admission test

Basic knowledge about:

- Ancient civilizations of the Mediterranean
- Methods for historical and archaeological research
- Medieval and modern history
- Computer hardware
- Digital representation of information and file formats
- Individual-productivity software (Microsoft Office or LibreOffice or Apple iWork or other similar servers and applications)
- Software for network communication (web, mail, etc.)

Students with disabilities and diagnosis of SLD

The verification of the adequacy of a student's preparation is carried out by means of individual interviews (oral test) aimed at assessing the basic level of knowledge as specified below. The test is mandatory as essential requirement for the registration for II Level degree course in European Heritage, Digital Media and the Information Society.

The verification of the adequacy of a student's preparation can be verified with an oral interview both in person and online (audio and video tools).

Deadlines for online submission of applications:

Admission test of September: From August 1st, **2019 to September 5**th, **2019** (within h 12.00 a.m.)

(the payment of the admission test fee should be done by September 6th, 2019)

Admission test of December: From November 1st, 2019 to December 5th, 2019 (within h 12.00 a.m.)

(the payment of the admission test fee should be done by December 6th, 2019)

Admission test of April: From February 2nd, 2020 to February 28th, 2020 (within h 12.00 a.m.)

(the payment of the admission test fee should be done by March 2nd, 2020)

Note:

1. It is worth remembering that, as already specified in art. 24 of the General Announcement of admission to the II level Degree Programs with limited enrolment for the academic year 2019/2020 (Bando Generale di ammissione ai Corsi di Studio a numero programmato ed ai corsi di laurea magistrale A.A. 2019/2020), students who have obtained their degree in universities other than the University of Salento must send a declaration according to the Italian law D.P.R. 445/2000, certifying the degree achieved, the exams taken, the ECTS obtained and the scientific-disciplinary sectors of reference at the Didactic Secretariat of the Department of Cultural Heritage at online address or the bandiaccessobeniculturali@unisalento.it by the deadline submitting the application. verifying the self-declarations made by the winners of the assessment test. This certification may also be sent by fax together with a photocopy of a valid identity document. The University will activate all the necessary controls aimed at verifying the declarations submitted; whether they will turn out to be false or mendacious, it will adopt the necessary forfeiture measures, also reporting the case to the competent Authorities for the application of the appropriate sanctioning measures as displayed in the art. 76 of the D.P.R. 445/2000.

2. With reference to the graduating students of the University of Salento, the provisions contained in the art. 22 of the current "Regolamento Didattico di Ateneo ai sensi del D.M. 270/04" are applied.

Application form for the admission to the test:

The application form must be submitted exclusivly online within no later than September 5th, 2019 h. 12.00 am.

In order to complete the online submission of applications, students are expected to connect to the site https://studenti.unisalento.it (Student Portal - authentication procedure - LOGIN) and follow the guided procedure by entering the information requested by the system.

Candidates must pay \leqslant 23,00, that is the amount for the admission test reservation fee as established by the Student Regulations in force for the academic year 2019/2020 in accordance with the procedures established by the University, as follows:

- payment by "pagoPA" the amount of \leq 23,00 as booking fee for the assessment test as determined by the Student Regulations in force for the academic year 2019/2020, by the deadline for the presentation of the application in order to participate at the test, as reported in the specific notice published by the Department.

The payment of the amount of $\leq 23,00$ as foreseen by the Student Regulation in force for the academic year 2019/20 must be made no later than September 6th 2019 in one of the following ways:

- "Pay with PagoPA" , in order to proceed immediately with online payment through the links managed by the student web portal, following the GOVPAy process proposed by the system

- "Print notice for PagoPA" for postponed payment to be processed at affiliated shops. In this case, the portal generates the pdf of the payment notice, that can be used for payment at one of the affiliated shops or credit institutions (including tobacconists who offer the Sisal Pay service or Lottomatica).

It is possible to proceed at the same time with the registration to more tests; in this case the student, after completing all the application forms, should pay the fee for each test he intends to book.

The test booking fee of \le 23,00 will be refunded / compensated to all students enrolling in the II level degree course for the academic year 2019/2020.

Except for the cases above mentioned, the participation fee for the test will not be returned and nothing can be requested from the University of Salento for any reason or cause.

The submission of the applications for participation at the test will be allowed, online, within the 7 days before the day set for the test.

Regular students of the University of Salento can also take part at the assessment test for personal preparation, i.e. those who are enrolled in the third year of a I level degree course and who plan to achieve the degree by the extraordinary session. They must have the curriculum requirements for the enrolment in the II level degree course and must still acquire no more than 30 ECTS to complete the training process.

The assessment will consist of an oral test conducted by a commission appointed for the purpose by the Department. It will be aimed to verify the candidate's knowledge in the relevant areas of study.

Successful candidates will be allowed to enrol in the degree course.

In any case, the tests will be preceded, for each candidate, by the verification of the existence of the curriculum requirements as specified above.

Terms and place of publication of the test results

Test results for each Degree Course considered, will be published on the official website of the University https://www.unisalento.it/albo-online, and on the section DIDATTICA of the Department of Cultural Heritage https://bbcc.unisalento.it.

Results will be published in accordance with art.8 of Law 241/90. No direct communication will be sent to the candidate.
