Ferdinando Spina is assistant professor of Sociology of Law at the Department of History, Society and Human Studies (DSSSU), University of Salento. In 2008, he received his Ph.D. in “Sociology of Everyday Life and Qualitative Research Methods” from University of Salento. He has been a fellow researcher from 2009 to 2011 at the Department of Social Sciences and Communication of the same university. He obtained the National Scientific Qualification (“Abilitazione Scientifica Nazionale”) for the position of Associate Professor in Political Sociology, Sociology Of Law (14/C3) (since 2017) and in Sociology of Culture and Communication (14/C2) (since 2018).

He has been visiting Ph.D. candidate at the University of Trier (Germany), visiting scholar at the International Institute for the Sociology of Law, Oñati (Spain), visiting researcher at the Faculty of Arts and Design/School of Humanities, Coventry University (UK), and at the Center for Industrial Technology Economy and Management (CITEM), Jinan University (China). In 2013-2014, he was Principal Investigator of the research project "Development policies and governance models in Puglia. New tools for knowledge and action", funded by the research program for emerging scientific excellence of the University of Salento. He participates in several national and international research groups, among which the Working Groups in “Law and Popular Culture” and “Sociology of Constitution” of Research Committee on Sociology of Law, ISA (International Sociological Association) and the Foundational Economy Collective.
